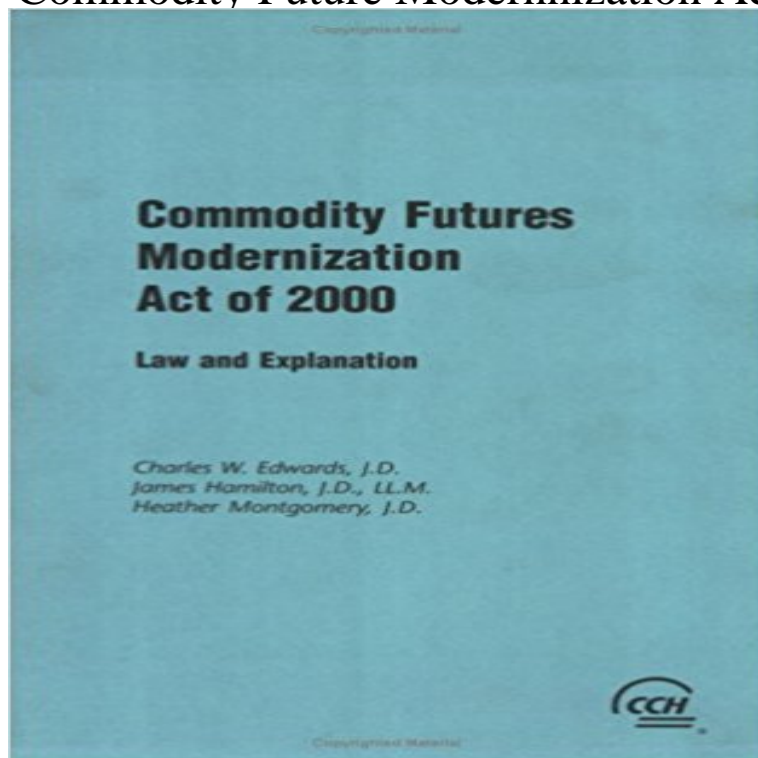


Commodity Future Modernization Act 2000: Law & Explanation
