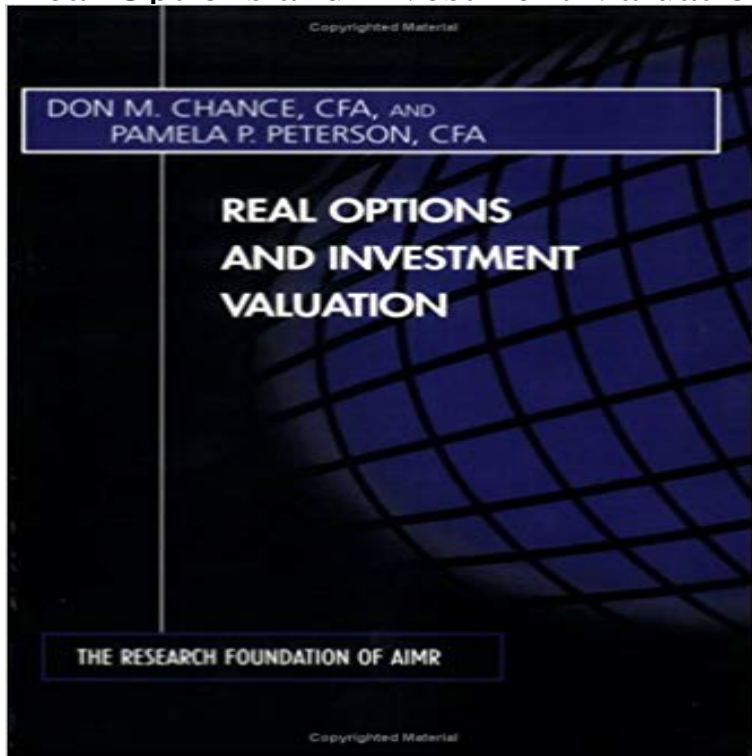


Real Options and Investment Valuation
