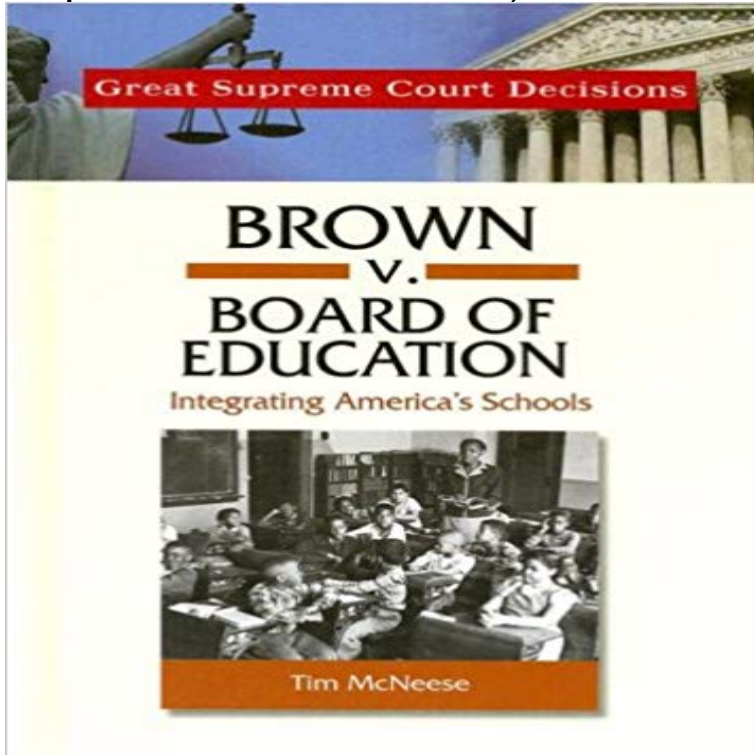


Brown v. Board of Education: Integrating Americas Schools (Great Supreme Court Decisions)
