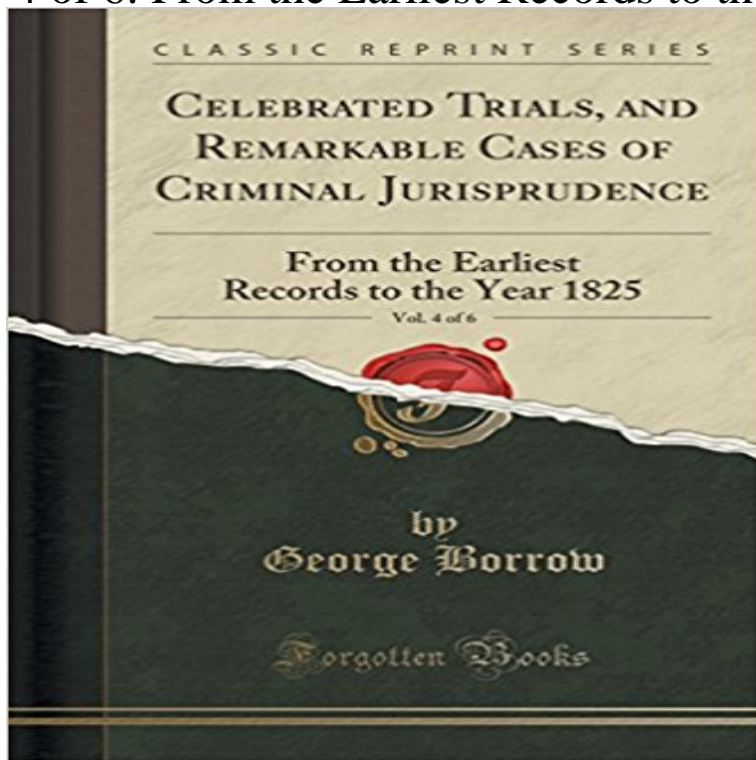

It will be a caution after he is dead to his successors, of what fatal consequence any sort of assuming may be.
