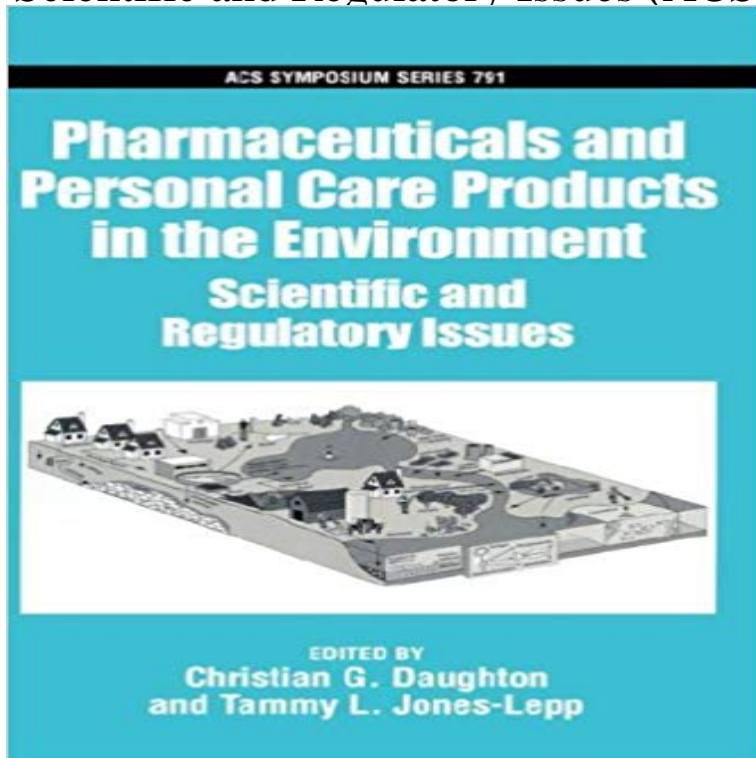


Pharmaceuticals and Personal Care Products in the Environment: Scientific and Regulatory Issues (ACS Symposium Series)
