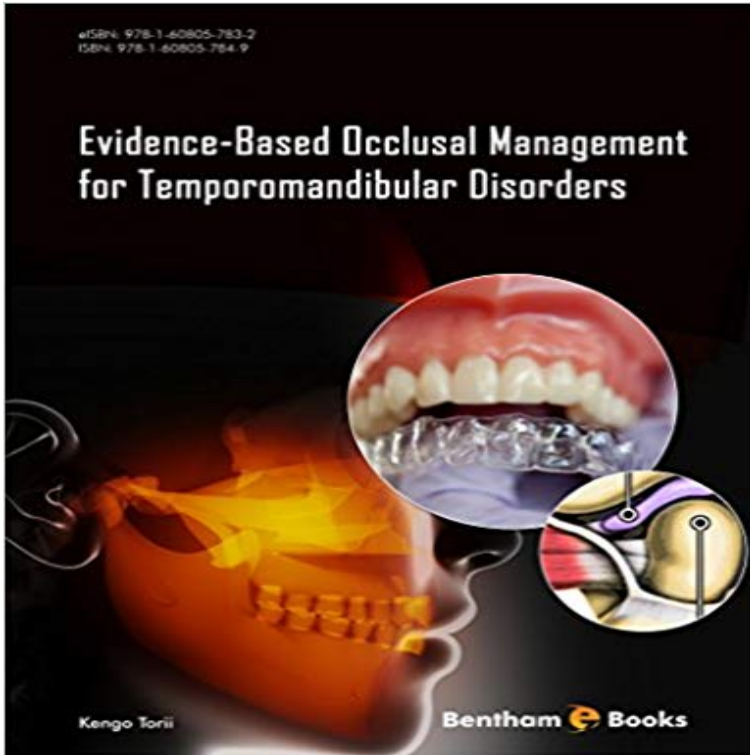


# Evidence-Based Occlusal Management for Temporomandibular Disorders
