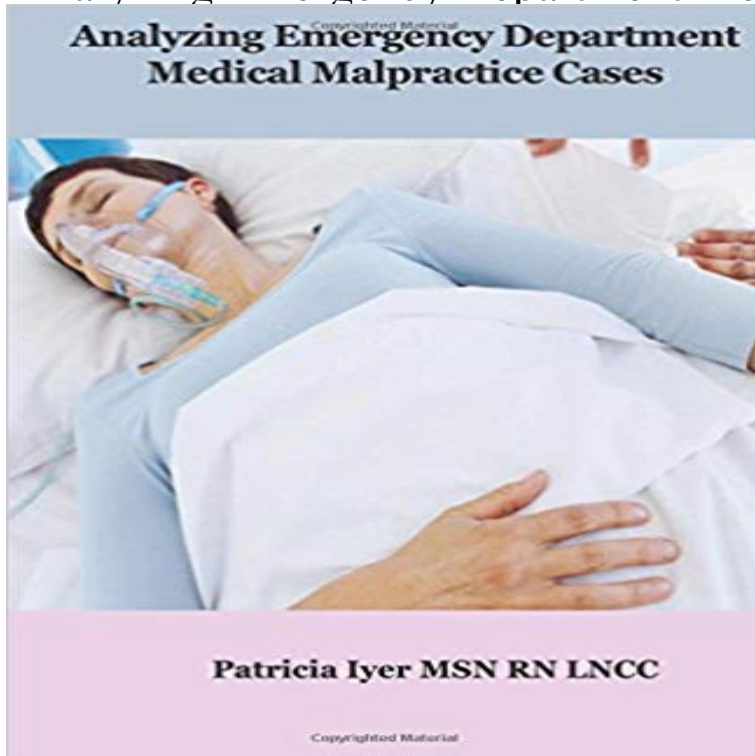


## Analyzing Emergency Department Medical Malpractice Cases
