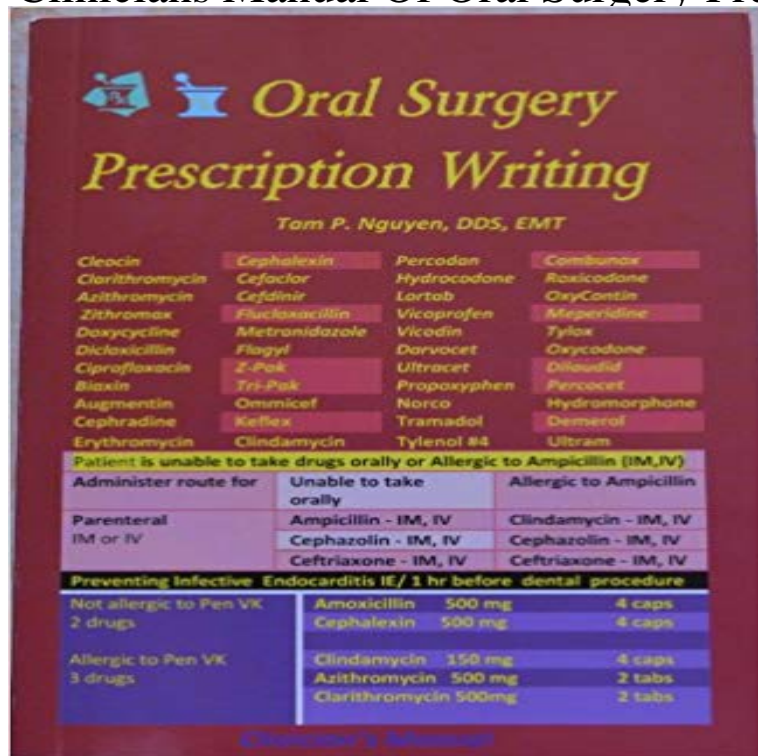


# Clinicians Manual Of Oral Surgery Prescription Writing
