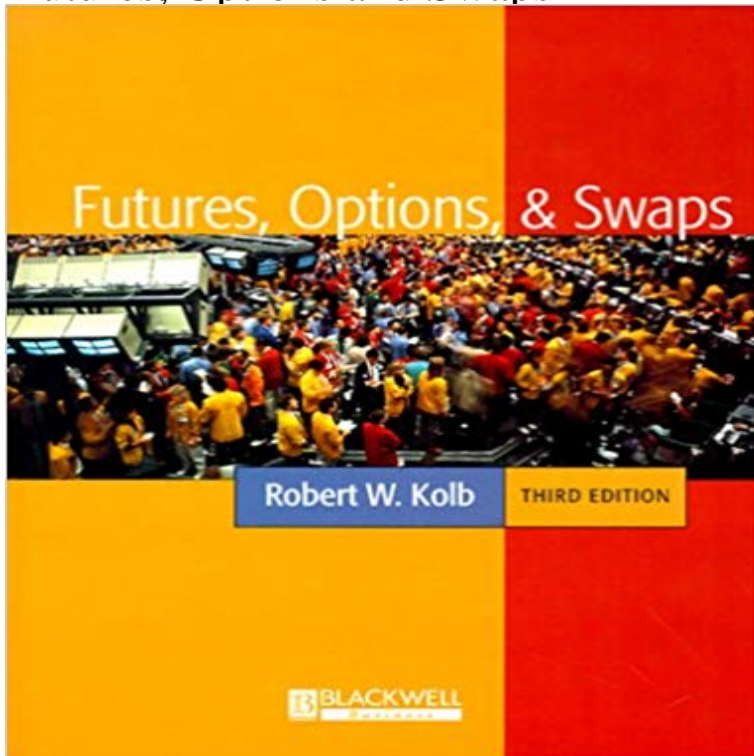


Futures, Options and Swaps
