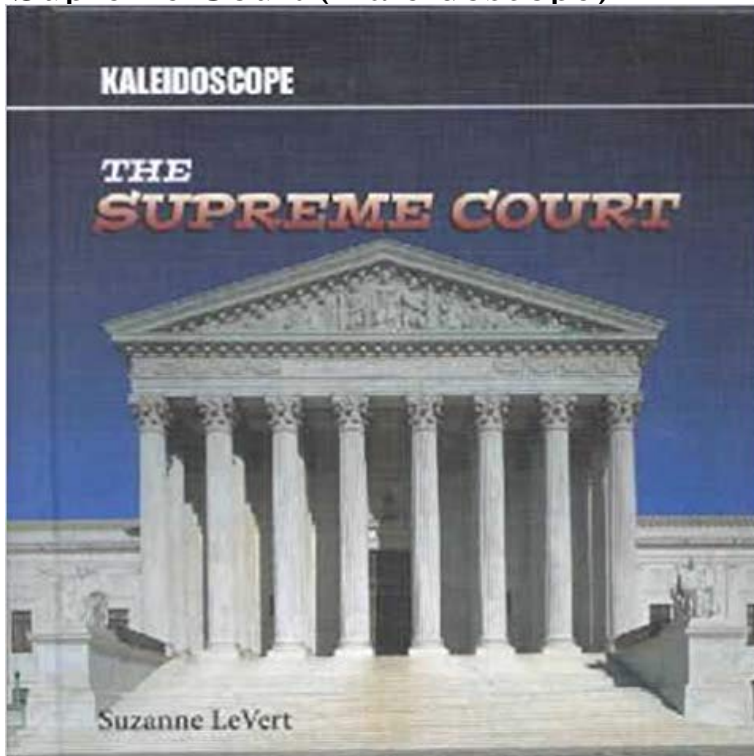


Supreme Court (Kaleidoscope)
