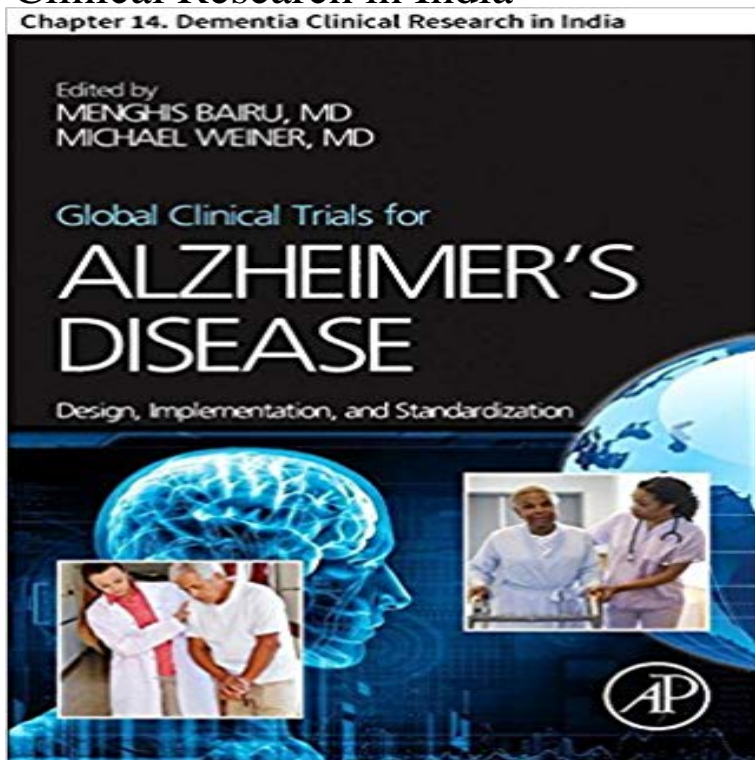


# Global Clinical Trials for Alzheimers Disease: Chapter 14. Dementia Clinical Research in India

A solid and general clinical research culture and a supportive healthcare system, both tailored to the specific needs of the dementia field and its vulnerable patient population, will have to be established through careful guidance of government regulators and collaborations with academic, industry and public stakeholders both in and outside India.
