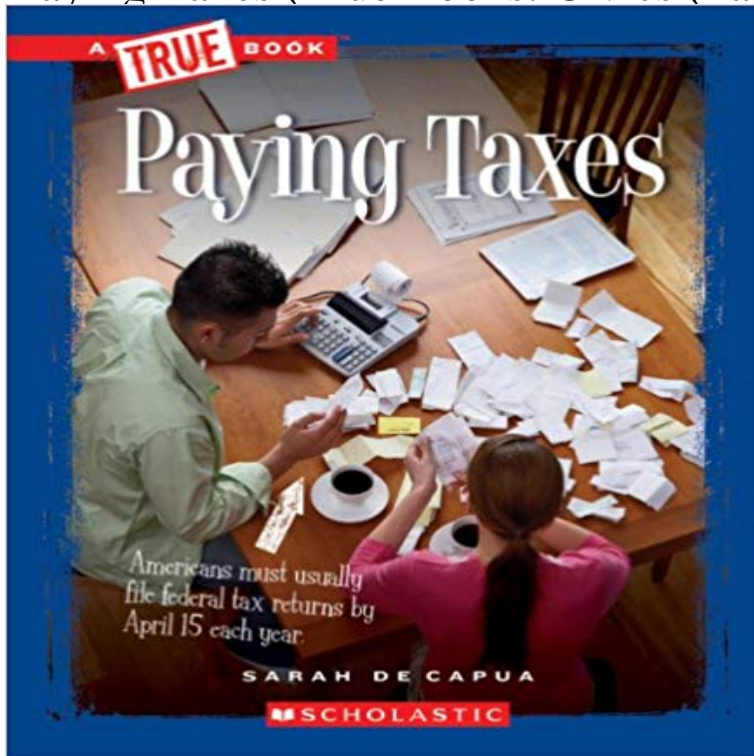


## Paying Taxes (True Books: Civics (Paperback))
