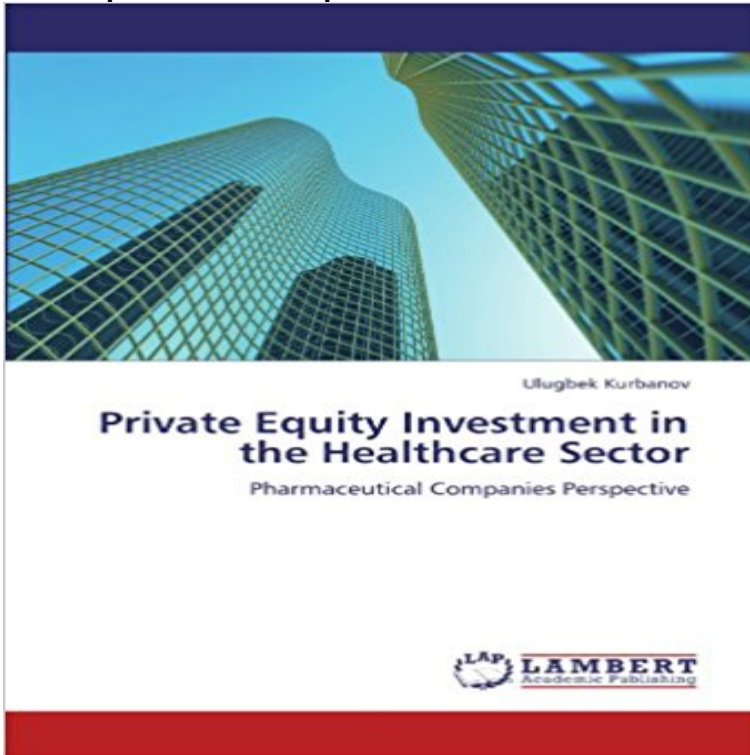


Private Equity Investment in the Healthcare Sector: Pharmaceutical Companies Perspective
