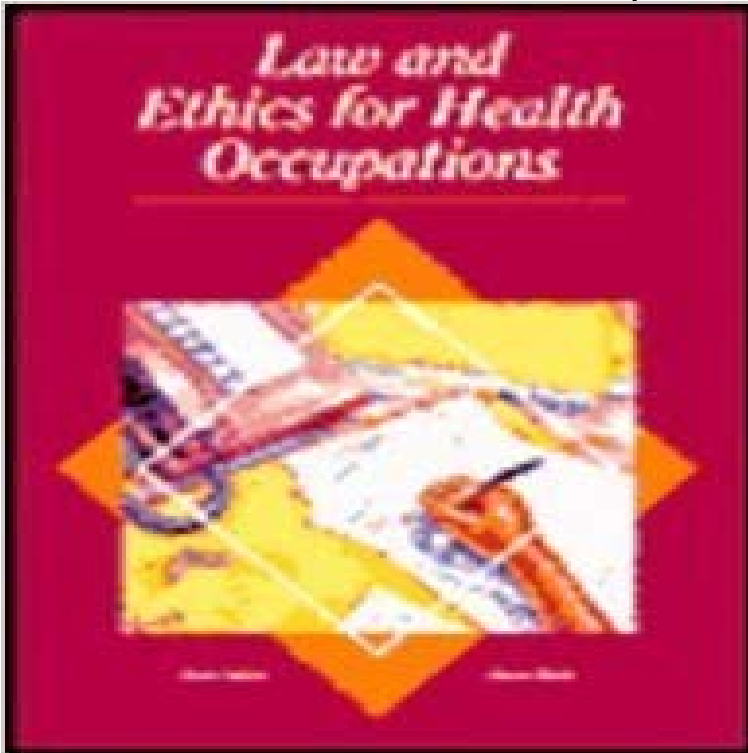


Law and Ethics for Health Occupations
