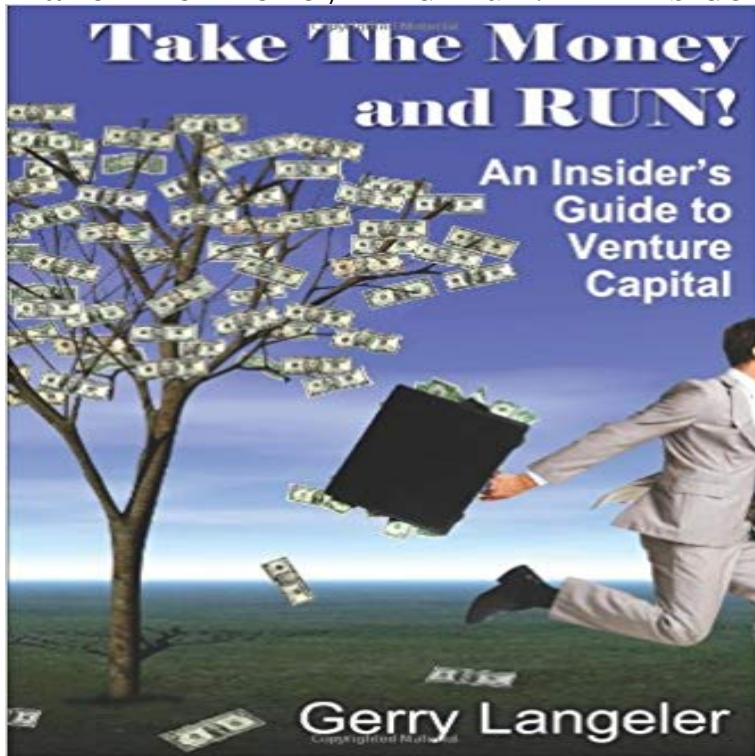


Take The Money And Run! An Insiders Guide To Venture Capital
