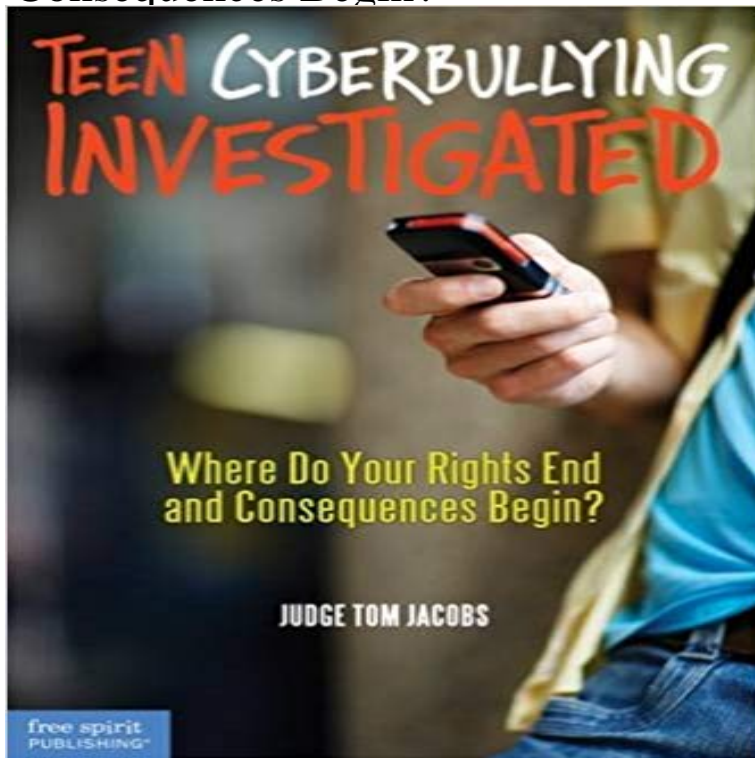


## Teen Cyberbullying Investigated: Where Do Your Rights End and Consequences Begin?
