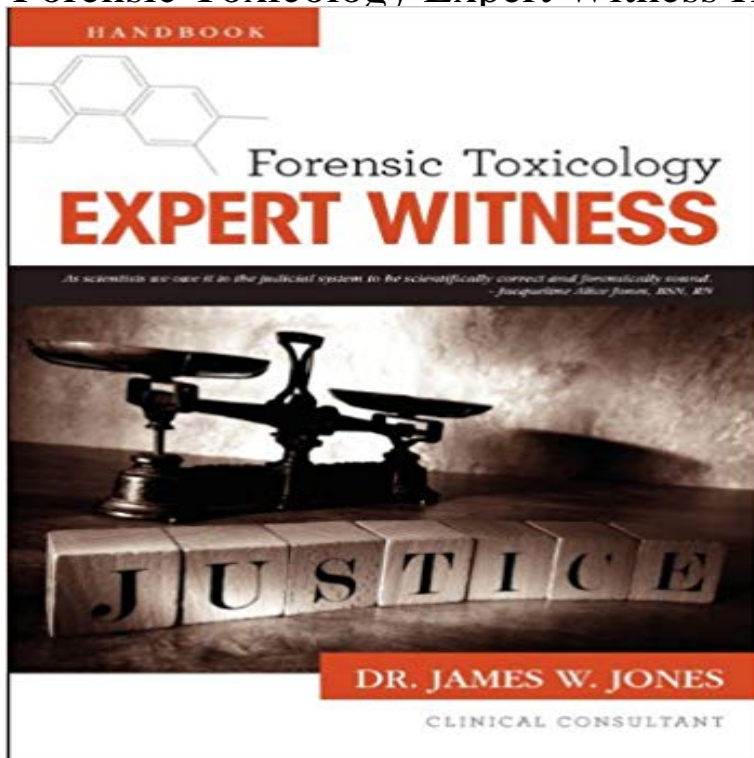


Forensic Toxicology Expert Witness Handbook
