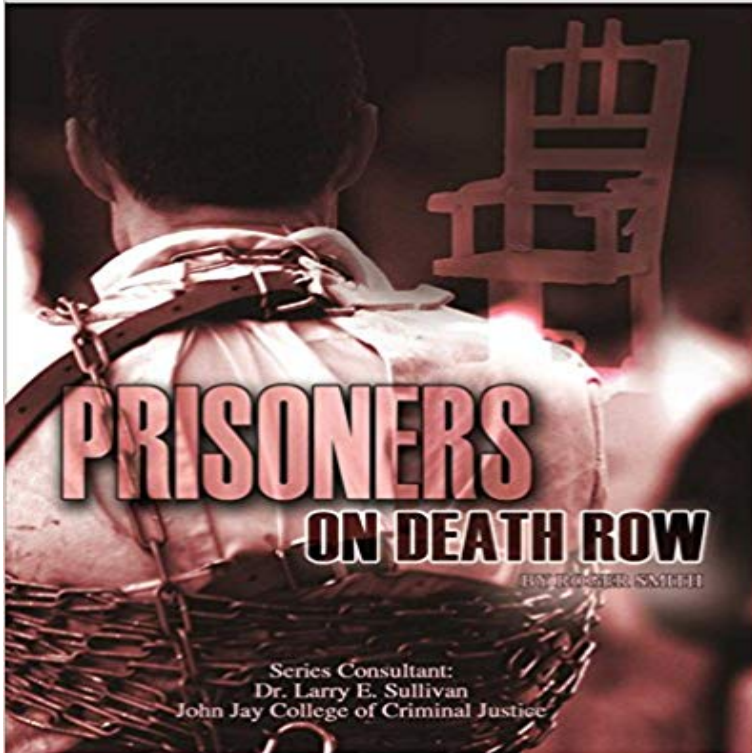


Prisoners on Death Row (Incarceration Issues: Punishment, Reform)
