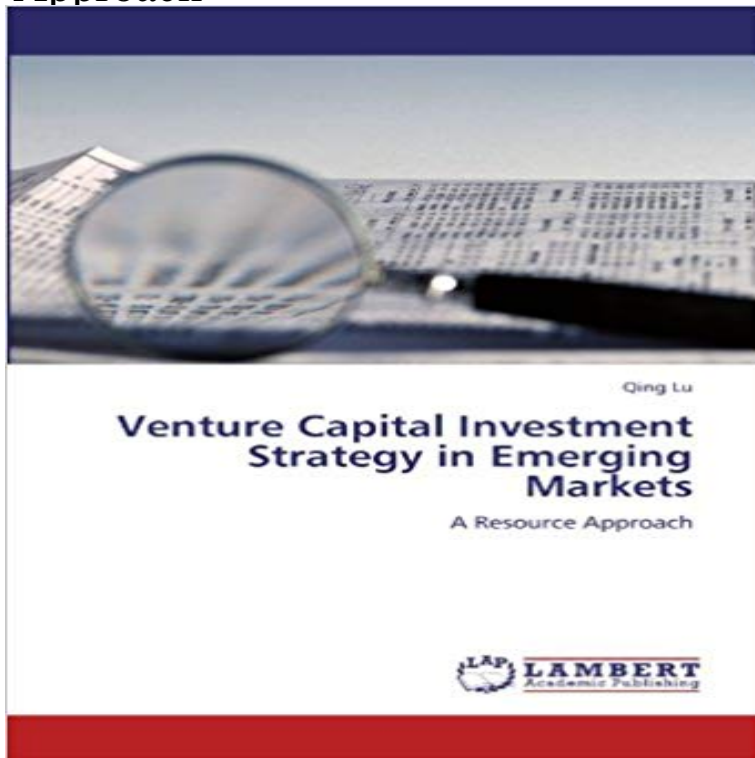


# Venture Capital Investment Strategy in Emerging Markets: A Resource Approach



In this study, I apply resource theory and knowledge-based theory to analyze the competitive advantage of venture capital (VC) firms in emerging markets and explore how VC firms accumulate their knowledge and build networks through their investment strategies in such markets. Four mechanisms for knowledge accumulation are summarized, namely, learning by jointing venture, learning by hiring, learning by doing, and learning by observing. My research has found significant differences between foreign and local VC firms in their investment decision process and syndication strategy. This study has also shown that VC knowledge affects its usage of learning mechanisms and together they affect VC investment strategies in emerging markets. The study is especially useful for venture capitalists in emerging markets as well as government policy makers in these countries.
