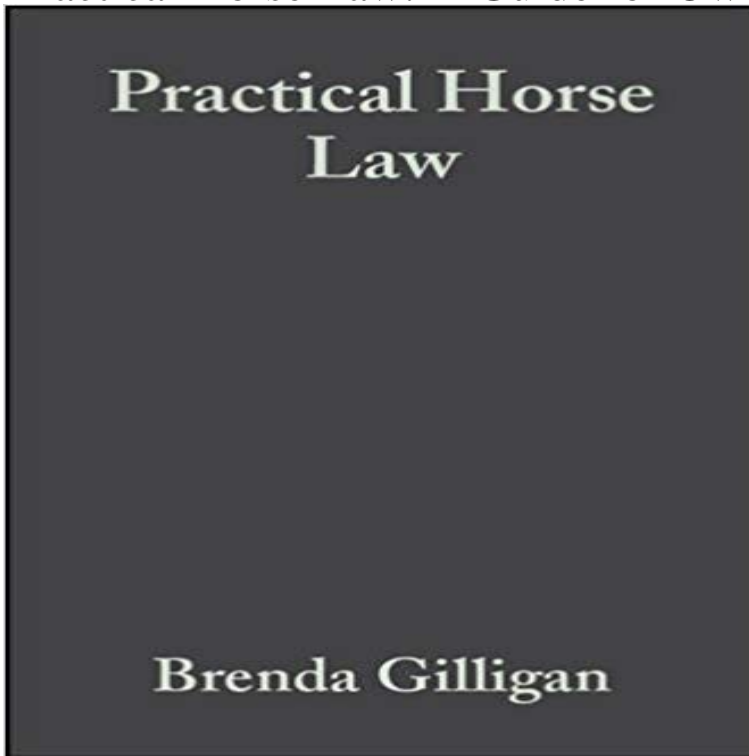


## Practical Horse Law: A Guide for Owners and Riders
